Course Overview:

The Digital Forensics course provides students with the knowledge and practical skills required to investigate digital crimes, collect and preserve digital evidence, analyze computer systems and network traffic, and support legal proceedings. The emphasis is on understanding forensic methodologies, legal and ethical considerations, and using forensic tools to extract and interpret evidence from digital devices and environments.

Course Objectives:

1. To understand the fundamental concepts, principles, and importance of digital forensics in cybercrime investigation.
2. To study forensic investigation procedures, evidence collection, preservation, and analysis techniques for digital systems.
3. To learn methods for investigating computer systems, networks, emails, web activities, and mobile devices.
4. To analyze legal and ethical aspects related to digital evidence, cyber laws, and forensic procedures.
5. To develop the ability to use digital forensic tools and techniques for detecting, investigating, and preventing cybercrimes.

Course Outcomes: After Completion of the Course, Students should be able to

1. Apply the foundational principles of computer and digital forensics in case analysis.
2. Analyze various types of electronic communications and their relevance to investigations.
3. Analyze the workflow of law enforcement during evidence collection and probable cause establishment.
4. Evaluate forensic reports and case documentation for completeness and legal validity.
5. Evaluate the implications of IT Act 2000 and 2008 amendments in digital forensic practices.

UNIT - I: Digital Forensics Science: Forensics science, computer forensics, and digital forensics.

Computer Crime: Criminalistics as it relates to the investigative process, analysis of cyber criminalistics area, holistic approach to cyber-forensics.

UNIT - II

Cyber Crime Scene Analysis:

Discuss the various court orders etc., methods to search and seizure electronic evidence, retrieved and un-retrieved communications, Discuss the importance of understanding what court documents would be required for a criminal investigation.

UNIT - III

Evidence Management & Presentation:

Create and manage shared folders using operating system, importance of the forensic mindset, define the workload of law enforcement, explain what the normal case would look like, define who should be notified of a crime, parts of gathering evidence, Define and apply probable cause.
